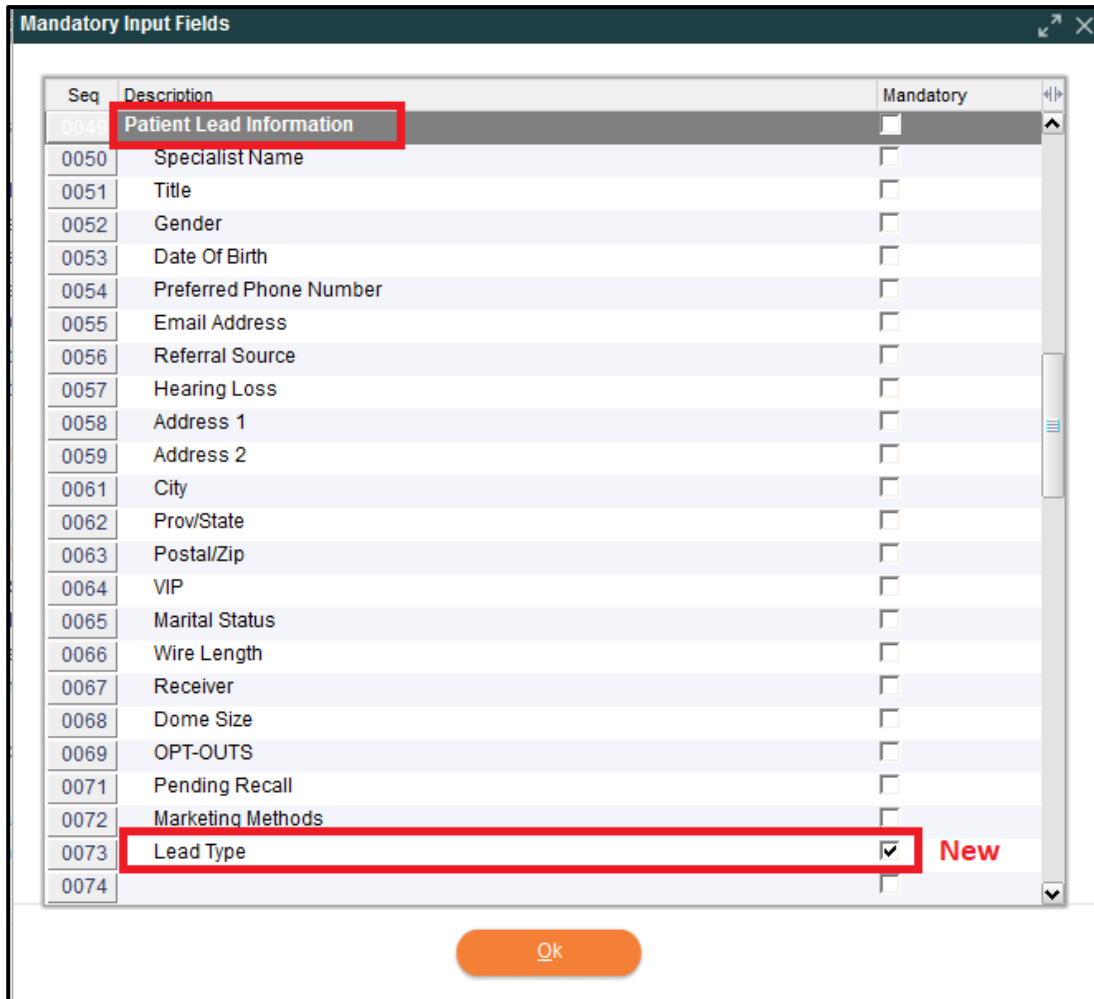
1 Introduction

The purpose of this document is to provide an overview of all the new and modified features within Aurora release version 6.20.

2 Enhancement to mandatory input fields configuration for patient leads

A new option to configure the LEAD TYPE as a mandatory field within DOCUMENT PARAMETERS > MANDATORY INPUT FIELDS has been added. This allows clinics to indicate that users must select a LEAD TYPE within the PATIENT LEAD INFORMATION screen before saving.



3 Enhanced filters available within the user activity log

The USER ACTIVITY LOG has been enhanced to have new search filter options for LOCATION and USER. Both selection criteria options include an ALL or SEL option.


This allows clinics to run the report for multiple users across multiple locations.

4 New data available on the recall inquiry

The RECALL INQUIRY has been improved to include more data on the Excel output. The new columns of data are for “Date of Birth” and “Title” and this new patient demographic data will be helpful for those clinics utilizing the RECALL INQUIRY for marketing initiatives.

5 New search option within manual NHAX reconciliation

The MANUAL NHAX RECONCILIATION function has been enhanced to help users search for a patient’s imported audiograms using either their first or last name. This search option is case-insensitive and helps users who are importing a considerable amount of audiogram data into Manage to find a specific record/patient.

6 Aged A/R report and inquiry enhancements

The AGED A/R Inquiry and the AGED A/R Report have had their Excel outputs modified to include INVOICE REGION, INVOICE LOCATION, and INVOICE SPECIALIST details.

7 Payments and deposits report enhancements

The PAYMENTS AND DEPOSITS REPORT has had its Excel output modified to include INVOICE SPECIALIST details.

8 Sales tax collected report enhancements

The SALES TAX COLLECTED report has been enhanced to include a new DOCUMENT TYPE column on the output file that indicates “I” for Invoice and “R” for Repair.
